#### **ABSTRACT**

**IIS JANUAR, 1211202809**, English Education Study Program, the Faculty of Teacher Training and Education, Widya Dharma University, Klaten, 2016. Thesis: "A Descriptive Study on The Mastery of Reading of the Eleventh Year Students of MAN Karanganom Klaten in Academic Year of 2016/2017"

The problem of this study is "How is the mastery of reading of the eleventh year students of MAN Karanganom Klaten in Academic Year of 2016/2017?" This study aims to describe the mastery of reading of the eleventh year students of MAN Karanganom Klaten in Academic Year of 2016/2017.

In this study, the writer takes all of the eleventh year students of MAN Karanganom Klaten as the population. The number of the population is 176 students. They come from 7 classes. Therefore, the writer takes 20% from them or 35 students as the sample by using proportional random sampling. It means that the writer takes 5 students for each class to be selected as the sample by lottery. In collecting the data, the writer gives a test that consists of 20 items in the form of multiple choices. The writer analyzes the data by using statistical method. It is implemented in the form of mean and table to know the student's mastery of reading.

After analyzing the data, the writer knows the students who get very good marks are 19 students or 54. 28%, those who get good marks are 13 students or 37. 14% and fair mark are 3 or 8. 58%. Besides that, there is no student who gets poor mark and fail mark. The mean of the students' mastery of reading is 80. 14 and it is classified into good category. So, the writer concludes that the mastery of reading of the eleventh year students of MAN Karanganom Klaten in Academic Year of 2016/2017 is good.

#### **CHAPTER I**

#### INTRODUCTION

## A. The Background of the Study

Language is a means of commmunication. Language is used to transfer one's idea to other. According to Brown (2000: 5) language is a system of arbitrary conventionalized vocal, written or gesture symbol that enables members of a given community to communicate intelligibly with one another. From the statement above, language can be used to communicate, to know, and to conceive social relationship between humans. Without language, humans cannot interact to each other. One of the languages which is used by humans in this world is English.

Because of the importance of English, Indonesian government has established a program that the students should study English as the foreign language. It is one of the compulsory subjects which is taught and learned in schools. English as the foreign language is taught in Kindergarten, Elementary School, Junior High School, Senior High School and Elementary School as a subject in school.

Pendidikan (SNP) or National Standard of Education on section 2 states that: Lingkup Standar Nasional Pendidikan meliputi: standar isi, standar proses, standar kompetensi lulusan, standar pendidik dan tenaga kependidikan, standar sarana dan prasarana, standar pengelolaan, standar pembiayaan, dan standar penilaian pendidikan. (The national standard of education consists of content standard, process standard, graduate competence standard, educator and

educational employees' standard, instrument standard, management standard, financial standard and educational assessment standard).

The content standard covers materials and competence level to achieve graduate competence at certain type and level of education. The process standard at all educational units is done interactively, inspiringly, fun, challengingly to motivate students to participate actively and to give them an adequate space for their initiation, creativity, and independency which is suitable with their talent, interest, as well as physical and psychological development. That is why, the teaching and learning process plan consists of syllabus and lesson plan which has at least the objectives, materials, methods, learning sources, and assessment.

The application of content standard in English subject for *Madrasah Aliyah Negeri (MAN)*, a primary high school level, is regulated on *Peraturan Menteri Pendidikan dan Kebudayaan* No. 68 section 1 verse 1 in 2013. It is said that the content standard for Senior High School includes the minimum material and the grade of minimum competency standard to achieve the minimum graduation competency in the grade and kind of the certain education. The teaching and learning English for *MAN* students consists of listening, speaking, reading, and writing.

Based on the application above, teaching and learning activities in English class for *MAN* students cover four skills (listening, speaking, reading, and writing). All those skills cannot be separated as they complete each other. Reading is one of the language skills which plays an important role for language acquisition. The acquisition process will be more successful when reading texts is very interesting and engaging.

In this study, the writer wants to describe about reading skill. According to Richards and Renandya, reading as one of skills in language has to be taught as well as possible. Reading, in many second or foreign languages teaching situation, receives a special focus (2002: 273).

According to Grabe, reading is something many of us take for granted. The reader reads with what appears to be little effort and planning (2009: 4). In this research, the writer pays attention to the test, will give assumption that giving more attention to reading skills will give better achievement. That is by giving more exercises and more time allotment to the teaching and learning process. In reading comprehension the English text from the students depend on their knowledge of the subject.

Through reading students can get information, knowledge, enjoyment and even problem solution. Therefore, the ability to read the text in any form will give a great deal of advantages in students' life. Reading becomes the main aim of language teaching which is as a skill and a part of the teaching program. It's purpose is to enable students to read and understand the text materials correctly.

Based on the explanation above, the writer is interested in conducting a research on the mastery of reading text of the eleventh grade students of MAN Karanganom. Therefore, this research is entitled "A Descriptive Study on the Mastery of Reading of the Eleventh Year Students of MAN Karanganom Klaten in Academic Year of 2016/2017".

## B. The Reason for Choosing the Topic

The reasons that encourage the writer to choose the topic are as follows:

- Reading as one of the four language skills has an important role in the teaching and learning English.
- Most of the students do not like reading English because they feel difficult to understand the meaning of the text.

The writer's aim of this study is to describe the students' mastery in

reading of the eleventh year students of MAN Karanganom Klaten in the Academic Year 2016/2017.

#### 3. Reading

Reading is a fluent process of readers combining information from a text and their own background knowledge to build meaning (Nunan, 2003: 68).

In this study, reading is a fluent process of readers' combining information from a text and their own background knowledge to build meaning of the eleventh year students of MAN Karanganom Klaten in Academic Year 2016/2017.

The mean of the students' mastery of reading is 70.14 and it is classified into good category. So the writer concludes that the mastery of reading of the eleventh year students of MAN Karanganom Klaten in Academic Year 2016/2017 is good.

#### 1. To the teacher

The teacher must be a guide and consultant when the students get problem in their study.
