#### ABSTRACT

**SRI WAHYUNI, 1211202772**, English Education Study Program, The Faculty of Teacher Training and Education, Widya Dharma University, Klaten 2016. Thesis "A Descriptive Study on The Mastery of Speaking of the Eighth Year Students of SMP N 3 Jatinom Klaten in Academic Year of 2016/2017"

This study aims at describing the students' mastery of speaking of the eighth year students of SMP N 3 Jatinom Klaten in academic year of 2016/2017. The population is the eighth year students of SMP N 3 Jatinom Klaten in academic year of 2016/2017. The number of population is 168 students divided 5 classes consisting of class VIII A = 31, VIII B = 30, VIII C = 32, VIII D = 31, and VIII E = 34. Therefore, by each class is taken 7 students or totaling 35 students (22.01%) as the sample. The study uses proportional random sampling technique. The instrument uses a spoken test by giving an instruction to the students to describe their favorite artist by orally. In analyzing the data uses statistic method which is implemented in the form of the mean. The tables are also used as bases to make description of the data since this is descriptive study. The findings show that the students who gain very good mark are 8 students (23%), good mark are 17 students (49%), fair mark are 9 students (26%), poor mark is 1 student (2%), and there is no student who gain fail mark. In this study, the mean score is 70.89 on the data analysis and it is categorized into good category. So, it can draw the conclusion that the mastery of speaking of the eighth year students of SMP N 3 Jatinom Klaten in academic year of 2016/2017 is good.

### **CHAPTER I**

#### **INTRODUCTION**

#### A. The Background of the Study

Language, as a means of communication, has an important role for human in the world, people talk about many things to one another by means language. Every language needs to express an idea and to interact with another people. English as an international language plays an important role in every aspect of human life, such as education, economy, social, politics, etc. Beside that, English is one of the foreign languages that have much function, and it is used in several countries as formal language and become second language in many countries.

Because of the importance of English, Indonesian government has established a program, that study English as the foreign language is given starting from Elementary School as the beginning level from the third level to sixth level until University. *Permendiknas No. 23 Tahun 2006* states that English language is one of the subjects in Junior High School.

Based on *Permendiknas No.23 Tahun 2006*, the various types of texts that are learned by the students of Junior High School are interpersonal text and transactional text. The purpose of teaching and learning English is that the student could master four skills, they are reading, writing, listening, and speaking. All of those skills cannot be separated from each other, especially is speaking. A productive skill that can be directly and empirically observed, those observations are invariably colored by the accuracy and effectiveness of test-taker's listening skill, which necessarily compromises the reability and validity of an oral production test as stated by (Brown, 2004: 140). Speaking is a difficult subject to be learnt by students. It is not an easy way for students to communicate in English. They are afraid of making mistakes in their speaking. They do not have confidence to speak in front of audience.

In speaking, there are so many classroom activities that can be used by teacher. They are acting from script, communication games, prepared talk, discussion, role play, discussion, and simulation. By using common technique, the students are expected to be able to speak freely. The degree of spoken pause can be limited.

Related to the language usage for interacting, the students should have a good speaking skill. In Junior High School, speaking skill means competence in expressing or communicating opinions, feelings, and ideas by doing speeches, dialogues, or producing utterances in front of the other students. The indicators of speaking skill are fluency, vocabulary, grammar and pronunciation (Brown, 2003: 184-185). By having a good speaking skill, they are being able to make interaction with all kinds of people around the world so that they can apply the knowledge to the world of work. The students find that the language they have learned is very useful for their life and job.

In this study, the writer wants to describe about speaking skill. Speaking as one of skill in language has to be taught as well as possible. Speaking is also the most language skill to asses reliably (Louma, 2004: ix). Research shows that ideas and information are more easily understood and processed through speech than through writing. From that statement, we know that speaking is very important skill, speaking help us to show idea, thought, and information to other. By speaking, we can share everything information and make the other understood about us.

Turk (2003: 5) says that one of the difficulties in speaking is that although we are always trying to present ourselves in a favorable light to others, we have little real idea of what we sound like to them.

There are a number of factors which affect the level of nervousness. These are the size of the audience, the importance of the audience, the difficulty of the subject, the experience of the speaker, and the vulnerability of his or her public persona (Turk, 2003: 78). Turk (2003: 5) adding the first problem for all speakers is being aware of them, and judging correctly their own part in what is, for many, an unfamiliar interaction. Quite a bit of the advice and discussion throughout the book is about how we achieve this useful self-knowledge.

Based on the explanation above, the writer is interested in conducting a research of descriptive study on the mastery of speaking of the eighth year student of SMPN 3 Jatinom Klaten. Therefore, this research is entitled "A **Descriptive Study on the Mastery of Speaking of the Eighth Year Students of SMP N 3 Jatinom Klaten in the Academic Year 2016/2017"**.

#### **B.** The Reason for Choosing the Topic

The reasons that encourage the writer to choose the topic are as follows:

1. Speaking is an interesting and essential skill to be learnt in the Junior High School to support the other skill; listening, reading and writing. That is why, it is very important to be learned by the students in order they can use a language as means of communication.

Furthermore, they have to always communicate with other English teachers, so that, when they got problems they can share with them.

2. To Students

The relation to the developing of their speaking skills and translating the sentence, it will be better for the students to practice speaking English outside the classroom. It is also necessary for them to improve their vocabulary and grammatical competence independently by drilling in remembering vocab.
