#### ABSTRACT

This study is intended to answer the question which becomes the problem of this study: How is the mastery of reading of the seventh year students of MTs Miftahul Ulum Ngawen, Blora in academic year 2014/2015? The aim of the study is to describe of the mastery of reading of the seventh year students of MTs Miftahul Ulum Ngawen, Blora in academic year 2014/2015.

3. Reading

Reading derives from the word *to* read meaning to reproduce mentally or vocally the words of books or other printed materials (Hornby, 1995: 710). He then defines *reading* as act of one who reads. Meanwhile, Dallman et al (1964: 7) define reading is not general ability, but a composite of many specific abilities. Reading involves skill, it involves thinking, considered in its broader sense it affects the entire personality.

Comprehension is the mind's act or power of understanding (Hornby, 1995: 175). So, reading comprehension can be defined as the understanding of a person as the result of reading printed material. Their understanding can be measured by someone else, for example: by asking the reader to answer some questions dealing with the material he reads.
