ABSTRACT

DEWI SELIYANA, 1311202841, English Education Study Program, the Faculty of Teacher Training and Education, Widya Dharma University, Klaten, 2017. Thesis: "A Descriptive Study on The Mastery of Reading of the Eighth Year Students of SMP N 3 BayatKlaten in Academic Year of 2016/2017".

The problem of this study is "How is the mastery of reading of the eighth year students of SMP N 3 BayatKlaten in the academic year of 2016/2017?" This study aims to describe the mastery of reading of the *Eighth Year Students of SMP N 3 BayatKlaten in Academic Year of 2016/2017*".

In this study, the writer takes all of the *Eighth Year Students of SMP N 3 BayatKlaten* as the population. The number of the population is 193 students. They come from 6 classes. Therefore, the writer takes 15% from them or 30 students as the sample by using proportional random sampling. It means that the writer takes 5 students for each class to be selected as the sample by lottery. In collecting the data, the writer gives a test that consists of 20 items in the form of multiple choices. The writer analyzes the data by using statistics method. It is implemented in the form of mean and table to know the student's mastery of reading.

After analyzing the data, the writer knows the students who get very good marks are 18 students or 60%, those who get good marks are 11 students or 37% and fair mark is 1 student or 3%. Besides that, there is no student who gets poor mark and fail mark. The mean of the students' mastery of reading is 78 and it is classified into good category. So, the writer concludes that the mastery of reading of the eighth year students of SMP N 3 BayatKlaten in Academic Year of 2016/2017 is good.

CHAPTER I

A. The Background of the Study

According to Brown (2000: 5) language is a system of arbitrary conventionalized vocal, written or gesture symbol that enables member of a given community to communicate intelligibly with oneother. From the statement above, language can be used to communicate in a written, conversation and symbol which have the meaning to know the other people. Using language, not only do they express their ideas but also they can give information to the other. Without language, it is hard to them to communicate, and to understand what the other people say. One of the languages which is used in the world is English. Therefore, language is very important, especially English.

As an international language English has a very important position. English as the most prominent international language is used in all over the world. By knowing English well, people will be able to understand some information delivered via internet, newspaper, magazine as medium of communication. Today the growth of English in the world elevates to Indonesia. English is considered as the first foreign language to be taught in schools.

Based on the importance of the English language above, the purpose of teaching English is to have an awareness of the nature and importance of the English language to enhance the nation's competitiveness in a global society. By reading, students become familiar with the rhythm of English, and in the next it will start up natural and students will notice when a sentence or phrase does not seem right.

Reading is a fluent process of readers combining information form a text and their own background knowledge to build meaning. The goal of reading is comprehension (Nunan,2003:68). By reading the different kinds of material, the students can improve their ability of reading. The ability of reading the materials for foreign language is very important in mastering foreign language itself.

The introduction of English from an early age is intended to develop the ability to speak and be accompanied by action. Learning English needs routinepractice, especially in reading. It is because of the differences in vowels and diphthongs between Indonesian and English. The main cause that influences the difference of English and Indonesian is the manner to speak the consonants and vocals itself. The following matters not only faced by the students, but also the teachers. Reading mastery is one of the key to successful in Learning English.

Reading is one of the language skills which need to be taught in language classroom (Fauziati, 2010: 32). Reading skill plays an important role for language acquisition process will be more successful. As students learn to sound out letters and words, spelling comes easier. Also reading new words puts them in their mind for later use. Seeing how words are used indifferent context can give a better understanding of the word usage and definitions.

Reading is an essential skill for learners of English as a second language. For most of these learners, it is the most important skill to master in order to ensure success not only in learning English but also in learning in any content class where reading in English is required (Nunan, 2003: 69). Therefore, reading is not easy, but the students can learn English reading.

Based on the writer's experience, the students found difficulty in learning English. The factors such as the students feel difficult to read English because they have law vocabulary and grammar, so they can not comprehend the text; and some students feel that studying English is not pleasing, and their English teacher does not have time to solve their difficulty to learn English especially in reading.

From the explanation above, it is assumed that most of students deal with some problems in comprehending text. They did not understand what was the text about because they were lack of vocabulary. They were

uncomfortable with the language; therefore, they were easily frustrated when they found some difficult words. Furthermore, inability to apply reading strategy made the students have a problem in comprehending a text. Because of that the students read slowly word by word with the result that they were confused with the meaning of the text.

Reading has additional important benefits that can help students learn the language faster and more completely. According to *Permendiknas No.* 22 (2006: 360) the material of English lesson in Junior High School includes four language skills, they are listening, speaking, reading, and writing. As one of the four skills, reading is an important skill that must be learned. In this research, the researcher will focus on reading skill. *Permendiknas No.* 22 Tahun 2006 (2006:360) also states there are some types of text in reading such as interpersonal text and transactional text including in these types are recount, narrative, procedure, descriptive, and report. As a part of English skill, reading must be mastered by the learners. In addition, by reading well, the students are able to take the core of the text that they read. In real life, the students read different kinds of reading material, such as books, newspaper, magazine, and etc. it will help to improve the students' ability in reading English text.

Based on the statements above, the writer would like to conduct a research entitled "A Descriptive Study on the Mastery of Reading of the Eighth Year Students of SMP N 3 Bayat Katen in the Academic Year of 2016/2017.

B. The Reason for Choosing the Topic

The reasons that encourage the writer to choose the topic are:

- Reading skill is one basic skill in English that must be learnt by the students of SMP N 3 Bayat Klaten. By having good skill in reading, students will be easy in understanding the idea in the form of reading text.
- 2. Most of the students do not like reading English because they feel difficult to understand the meaning of the text.

This research is limited to the reading mastery of the Eighth year students of SMP N 3 Bayat Klaten in the Academic year of 2016/2017

Mastery means great knowledge about or understanding of a particular thing (Hornby, 2005: 944). In this study, mastery means the students' knowledge in answering the questions concerning with reading. It is indicated by students' marks gotten from reading test.

3. Reading

Richards and Schimdt (2002: 443) state that reading is perceiving a written text to order to understand its content. To do it successfully, we have to understand about the meaning of word, understand the arguments, and work out if we have to agree with them. When we do not do that thing, it makes us just scratch the surface of text and we have to forget it quickly.

In this study, reading is perceiving a written text in order that the eighth year students of SMP N 3 Bayat Klaten in academic year 2016/2017 understand the content of a text.
