#### ABSTRACT

**RATNA DENY FERAWATI, No : 1311202881**, English Education Study Program, Teacher Training and Education Faculty, Widya Dharma University, Klaten, 2017. Thesis: *A Descriptive Study on the Mastery of Reading of the Seventh Year Students of SMP Al-Islam Gatak Sukoharjo in Academic Year* 2016/2017.

The problem of the study can be stated as follows: "How is the mastery of reading of the seventh year students of SMP Al-Islam Gatak Sukoharjo in academic year 2016/2017?".

The research was done in the second semester of the academic year of 2016/2017 in SMP Al-Islam Gatak Sukoharjo. The population of the research is the seventh year students of SMP Al-Islam Gatak Sukoharjo in academic year 2016/2017. The number of the population is 40 students that are divided into 2 classes. All of the population is used as the sample. The technique of collecting data is test, which is in the form of multiple choice. The data are analyzed by mean.

Based on the data analysis, the mastery of the reading of the seventh year students of SMP Al-Islam Gatak Sukoharjo in academic year 2016/2017 is 73.125. #### **CHAPTER I**

## **INTRODUCTION**

### A. The Background of the Study

According to Hornby (1995:66), language is the system of sound and words used by humans to express their thought and feeling. It means that language idea and state it by using language. As social beings, people cannot be separated from language since they need to communicate to each other with a language as the medium. In this case, people able to express their ideas and feeling by using language.

English is one kind of language in the world and an international language. Many countries use English as a daily language for their communication. Consequently, people should be able to communicate in English as well as possible. In Indonesia, people use English as an international language and this language constitutes a foreign language that should be mastered.

Teaching and learning English for junior high school is a way to make the students master four language skills: listening, speaking, reading and writing. In learning those language skills, the learners start to listen and speak, after that, they learn to read and write.
