ABSTRACT

SRIYAMI WIJAYANTI, 1311202857, English Education Study Program, The Faculty of Teacher Training and education, Widya Dharma University, Klaten 2017. Thesis "A Descriptive Study on the Mastery of Reading of the Eighth Year students of SMP N 1 Ngawen Klaten in Academic Year 2016/2017".

This study is intended to answer the research question which becomes the problem of this study "How is the mastery of reading of the eighth year students of SMP N 1 Ngawen Klaten in Academic Year 2016/2017?". It aims to describe the mastery of reading of the eighth year students of SMP N 1 Ngawen Klaten in Academic Year 2016/2017

The writer takes all of the eighth year of students SMP N 1 Ngawen Klaten in Academic Year 2016/2017 as the population. The member of the population is 253 students. They come from 8 classes. Therefore, the writer takes 40 students of the population as the sample by using proportional random sampling. In collecting the data, the writer needs the instrument. The writer uses test as the instrument. And the form of test used in this research is multiple-choice. The number of the test item is 20. One option is right and the others are wrong. The students are expected to choose the correct answer. The 20 items must be done within 45 minutes. The writer tries out the instrument, before applying to the subject of the study. To know the validity the writer uses empirical validity using the Pearson's Product Moment Formula. To know the reliability of the instrument the writer uses Spearman Brown formula. In analyzing the data, the writer uses statistic method which is implemented in the form of the mean. The tables are also used as bases to make description of the data since this is descriptive study.

In this study, the writer can find that the mean is 69. The writer concludes that the mastery of reading of the eighth year students of SMP N 1 Ngawen Klaten in academic year 2016/2017 is good.

CHAPTER I

INTRODUCTION

A. The Background of the Study

Language is a means of communication that takes an important role in human life. Language roles as communication to the others. As social beings, people cannot be separated from the language. They need to express their opinion, emotion and desire either in speaking or conversation or dialogue. Brown states that language is a system of arbitrary conventionalized vocal, written, or gestural symbols that enable members of a given community to communicate intelligibly with one another (2000: 5). Based on the statement above, it can be said that language is used for communication. There are many languages used in this world, but English becomes the most important language to be mastered. As English is stated as the international language and most of the government in every country confirms that English becomes the first language that must be learnt beside of its own language, English is taught in every level of school and education institute, and nowadays it is also taught in early age as an introduction, including in Indonesia. Because English is as the international language, many countries including Indonesia apply English as academic subject in school and the other education institute. In Indonesia, English becomes a subject in educational program since Elementary School until University. English teaching and learning covers the four skills, they are listening, speaking, reading and writing skills.

Reading is a fluent process of readers combining information from a text and their own background knowledge to build meaning. The goal of reading is comprehension (Nunan, 2003: 68). In real life, people read different kinds of reading materials such as book, reference, newspaper, magazine, brochure, etc. By reading students will not only get new information but also increase their language knowledge such as the new vocabularies, phrases, idioms, and many more when they read various kinds of books. Reading mastery is one of the keys to be successful in learning English. Therefore, the introduction of English should be done from an early age.

English education in junior high school plays role to develop skills which have been introduced in elementary school. The introduction of English from an early ageis intended to develop the ability to speak and be accompanied by action. Conversation topics are related to those things that are within the context of the situation. In this case the students are encouraged by their friends. Learning English needs diligence and routine practice, especially in reading. The differences betwen English and Indonesia language could be one of difficulties in learning English. Besides the vowel and dipthongs, English and Indonesia language are also different in sentence structure, verbs of tenses, gender of personal pronouns, etc.

In classroom practice, Johnson (2008: 111–116) states that reading activities are divided into three stages. They are pre-reading activity, while-reading activity, and post-reading activity.

In pre-reading activity, the teacher and the students prepare them selves for the task and make them familiar with the topic. In while-reading the students interact with the text. The development of reading skills mostly occurs in this stage. The last step, post-reading activity is done after the students have finished reading the text. Before going to post reading, the students must confront the while-reading. The three steps of reading activities can't be apart, because every reader always tries to understand the topic, then they will interact with the text therefore, they will be able to answer the questions related to the text or do the tasks after they finished reading the whole text.

In learning process, the students are still hard and confused to understand what they read, especially in English text. Besides that, the students have minimum vocabulary, assume that English is difficult, have low motivation and etc. So, the teacher must be creative, hardworking, and need more effort to teach the students.

Based on the statements above, the writer would like to choose the title "A Descriptive Study on the Mastery of Reading of the Eighth Year Students of SMP Negeri I Ngawen Klaten in the Academic Year 2016/2017"

B. The Reason for Choosing the Topic

The reason why the writer has choosen this topic is thestudents of SMP/MTs tend to be imaginative; therefore, reading text is a suitable material for them in learning English as the foreign language.

the students use their knowledge when answering the task concerning with reading. While, Hornby (1995: 523) defines mastery as complete control or knowledge.

According to Longman (2001: 880) that mastery is complete control or power over someone or something. In this study, mastery means the students' capability on reading text effectively and efficiently.

Therefore, mastery is a knowledge and skill that allows you to do, use, or understand something very well.

3. Reading

According to Nunan (2003: 68), reading is the fluent process of readers combining information from a text and their own background knowledge to build meaning. Reading this study means a fluent process of readers combining information from a text and their own background knowledge to build meaning.

According to Johnson (2008: 3) reading is the practice of using text to create the meaning. If there is no meaning being created, there is no reading taking place.

So, a descriptive study on reading mastery of the eighth year students of SMP Negeri 1 Ngawen Klaten in the Academic year 2016/2017 means a fluent process of students combining a text and their own background knowledge to build meaning of the eighth year students of SMP Negeri 1 Ngawen Klaten in the Academic Year 2016/2017.
